6. Accidental release measures

Personal precautions, protective equipment and emergency procedures: Keep unauthorized personnel away. Keep upwind. Avoid inhalation of dust. Use personal protective equipment. Ventilate closed spaces before entering them. See Section 8 of the SDS for Personal Protective Equipment. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing.

Methods and material for containment and cleaning up: Avoid dust formation. Sweep up and place in a clearly labeled container for chemical waste. Clean surface thoroughly to remove residual contamination.

Notification Procedures: Prevent entry into waterways, sewer, basements or confined areas. Inform authorities if large amounts are involved.

Environmental Precautions: Prevent further leakage or spillage if safe to do so. Avoid discharge into drains, water courses or onto the ground.

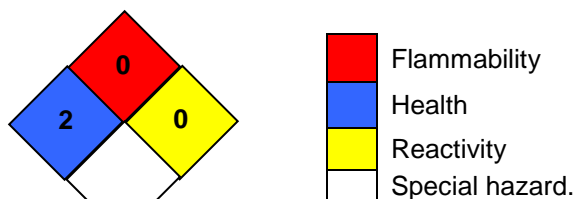
